The connection fee through June 30<sup>th</sup>, 2025 will be \$2,156.00, payable to Clear Creek Conservancy District. If you wish to mail this check, the P.O. Box can be found below, and Kathy Deer must receive this check before your connection can be made, so allow at least three business days for your check to arrive. If you'd prefer to avoid the mail, you can make arrangements with me to pick it up on site, or meet me at the sewer treatment plant on the southwest side of the lake by the dam. Currently, credit card payments for connection fees are not possible.

Please fill out sections 1 & 2 of the permit for our files. If we don't meet until the day of connection, you can scan and email or even take a picture and email/text me the permit. I just need the information in the first two sections. I'll fill out a new "official" form using this info once the connection is complete; and at that time, I'll send the completed permit to Putnam County Planning. They only accept sewer permits after the connection has been made for their Certificate of Occupancy release.

We also need a *Certificate of Insurance* on file with Clear Creek Conservancy District listed as the Certificate Holder from the excavator who will be tying in at the connection point in the easement. Usually, this is a matter of simply having your contractor contact their insurance agent. This certificate can be emailed to [wwtp.clearcreek@gmail.com](mailto:wwtp.clearcreek@gmail.com).

If schedule 40 PVC is used, backfill stone is only required at the sewer main connection point, and to support under any pipe that has been over dug, and it's recommended lateral ditches under driveways are filled with stone all the way to the surface. Clean-outs are required at the house, and every 100' where applicable. No Fernco type fittings are allowed.

Please give me a few days' notice before the connection so I can make arrangements for someone to be available for inspection. We are required to inspect the connection point where the lateral meets the easement, however we like to take pictures and reference measurements of the entire open ditch if at all possible, so we can have this information on file to assist with any future troubleshooting. Depending on current lot information, we may need to run a push camera once your contractor has the lateral exposed, to verify there is no fiber optics or other breaches in the lateral. This will not take long, but this is another reason it's important the contractor coordinate with us on timing of the connection in advance. If your lot has a shared lateral with an empty neighboring property, we'll supply your contractor with a 4" pipe to mark the wye before it's backfilled.

Fill out Parts I and II of this form and mail with sewer connect fee check to: Clear Creek Conservancy District, P.O. Box 286, Greencastle, IN 46135. Refer billing questions to 765-246-6585.

Once payment is made, homeowner or sewer contractor must call 317-371-8373 no less than three days in advance of hookup to schedule a time for inspection. All connections must be inspected by the district.

**Your sewer contractor must have provided a Certificate of Liability Insurance listing Clear Creek Conservancy District as an "additional insured" on file with the District.**
